

# **Privacy Policies - Honokeana Cove**

## ***Privacy Policy - Website***

**Everyone advises that a website needs a privacy policy. By using this website, you are accepting this policy.**

***Personal information:* This website does not store any personal information, and you may use the website without giving us any personal information. If you give us information such as your name, e-mail address and phone number when filling out the contact form or sending us e-mail, please see "Privacy Policy - Rental Office / Rental Agent" below.**

***Anonymous information:* This website may use Google Analytics or similar tools to measure how you and other visitors use the website. This information is anonymous and does not identify you as an individual, nor the computer you are using.**

***Visiting our website from outside the United States:* This privacy policy covers collection of information on the website from residents of the United States. If you are visiting the website from outside the United States, please be aware that your anonymous information may be transferred to, stored, and processed in the United States where this website's servers are located. The data protection and other laws of the United States and other countries might not be as comprehensive as those in your country.**

## ***Privacy Policy - Rental Office / Rental Agent***

***Personal information:* If you contact the Honokeana Cove Rental Office or Rental Agent to request information about vacation rentals, you may provide us with personal information such as name, e-mail address, phone number and number of adult and minor guests. We will maintain that information unless you ask us to delete it. We may use that information to contact you once in a while unless you ask to be taken off our mailing lists.**

***Sharing with condominium owner:* If you are a past or future guest in a Honokeana Cove condominium, the owner of that**

condominium is a party to the agreement that secures your vacation rental. Our owners sometimes like to contact their guests, and upon request by the condo owner we will share contact information for that condo's past and future guests.

***Credit card information:*** If you make a reservation with Honokeana Cove, we may ask you for credit card information to process a deposit and to pay for your rental. Your credit card information is used only for the current transaction. Credit card information is used only by the rental office and is not given to the condominium owner.

***How we protect your personal information:*** We protect your personal information with passwords, firewalls and other methods, using the same care as we do in protecting our own information. However, no system can be completely secure and we cannot guarantee that all information will always remain protected. ***Sharing of information:*** We will not sell your personal information or use it for any purpose except to encourage you to make future rentals at Honokeana Cove. Such information may be provided in response to a court order or legal requirement.
